This is a critical time for women's rights. As the leading representative organisation for women and women's organisations with almost 200 member groups across the island of Ireland, we are at the forefront of campaigning for women's rights and equality.

An exciting opportunity has come up to join our team as **Policy and Campaigns Officer leading our work on care as a feminist, social and economic issue**. If you are passionate about feminism and women's equality, have strong policy and advocacy skills, and enjoy working with women from diverse backgrounds to shape inclusive, impactful campaigns, we'd love to hear from you.

**We are looking for you to join the team based in Dublin. We work a hybrid model, with two days a week in the office. This post is for a part time (4 days/week) position for a fixed term 12 month contract.**

NWC is an equal opportunities employer and welcomes applications from all interested parties including people from diverse backgrounds and under-represented groups including ethnic minority groups and people with disabilities. NWC offers a number of flexible working arrangements.

The salary for this position is €38,873 per annum (pro rata), which equates to €31,098 for a four-day (0.8 FTE) working week.

The Policy and Campaigns Officer will lead on NWC's work in the area of care and support, shaping policy and campaigns that place care at the centre of women's economic equality, climate justice, health, and other key areas. This is an exciting opportunity to drive awareness and reframe how care is valued in Irish society. The role involves developing an inclusive, feminist model of care, grounded in evidence and lived experience. Key responsibilities include policy development, alliance building, public engagement, and campaign delivery, in close collaboration with NWC members and wider civil society.
