Job Description

Overview: Established in 2008 as part of the HSE Health Action Zone & Food Focus initiative, The Glen Community Garden, located within the grounds of The Glen Resource Centre, aims to help local people and communities gain access to quality, fresh fruit and vegetables. Using Community Development principles within the "Rapid" areas of Corks Northside, this role will guide and integrate urban sustainable food production in a community setting.

Over time, the garden's development has been overseen by volunteers, supported by a horticulturist advisor and community partners, ensuring its growth and commitment to sustainable development and health goals.

The Community Gardener will play a key role in sustaining and expanding the existing range of food-growing, biodiversity and sustainability projects at the Centre. This community setting encourages innovation and inclusion, enhancing local ecosystems through partnerships within the community garden network & Health Action Zones, Growing places for Wellbeing project.

The Community Gardener will bring extensive knowledge of organic food growing practices, distribution, and social innovation. They will be motivated to empower and activate community members, fostering connections with residents, volunteers, groups, local schools, and Centre staff.

Principal Duties and responsibilities

- Develop the community food garden in collaboration with the Community Garden Coordinator, volunteers, and centre staff.
- Utilize organic gardening practices with a focus on abundant seasonal fresh produce
- Work to enhance biodiversity and climate action goals in food production methods
- Maintain good environmental, health, and safety practices.
- Learn about the Community Health model and connect community gardening to broader social, health, and environmental benefits.
- Participate in supervision and training as required.
- Develop collective responses to needs within the community, including those experiencing social exclusion.

- Promote inclusive ways of working in order to secure concrete improvements in quality of life for the community
- Focus on empowerment, user-participation, collective action, partnership and inter-agency working, being respectful of individuals and their communities, promotion of social inclusion and accountability.
- Seek to support, guide and strengthen the capacities of the community for positive health and equitable health outcomes.
- Support the work across community agencies.
