#### Purpose of the Job

The role of Night Team Leader is vital to the successful delivery of quality programmes and services in NOVAS for our clients. The Night Team Leader will support the clients of NOVAS in STA services located in Dublin (Rathgar and Rathmines services).

The Night Team Leader will report to the Group Service Manager and work collaboratively with the NOVAS STA Services staff team and wider NOVAS services. The Night Team Leader will work closely with external service providers, local authorities and local communities in the region. The Night Team Leader is responsible for managing and supervising night staff, maintaining a high standard of service delivery, ensuring that the service provision is person centred, effective, safe and promotes positive health and wellbeing for clients. The Night Team Leader will ensure the service is compliant with relevant legislation, regulations, national, organisational and local policies and standards. The Night Team Leader will ensure effective day to day running of the project especially at evening and night time, all aspects of health and safety are met, the hygiene and physical environment is kept to a high standard and ensure that clients are consulted and involved in the operation of the project to the greatest practical extent. The Night Team Leader will be part of the NOVAS emergency contact rota, carry out administrative and financial procedures in accordance with the policies and procedures of NOVAS, prepare reports, statistics and other information as required.

This role includes predominantly evening and night work, weekend and some very early mornings (8, 10 and 12 hour shifts). You will be required to support the night team members through regular team meetings and supervision, induction and probation meetings

This job description is a guide to the general range of duties assigned to the post holder. It is intended to be neither definitive nor restrictive and is subject to periodic review.

### JOB DESCRIPTION



NOVAS is a not for profit organisation and Approved Housing Body, we work with single adults, couples and families, and who are homeless or at risk of being homeless. We also provide a service for unaccompanied minors seeking asylum. We support adults with disabilities and complex needs. We provide a range of services and accommodation. Our first service was established in Limerick in 2002 which was a temporary low-threshold emergency homeless accommodation and we have grown from there. We now have over 300 staff, and more than 30 services in Limerick, Dublin, Clare, Kerry, Cork and Tipperary including emergency homeless accommodation, transitional homeless accommodation, social housing and community based services for tenancy sustainment, homelessness prevention, mental health and recovery.

NOVAS is a Trauma Informed Practice Organisation and the principles of collaboration, diversity, respect and trust are embedded in our way of working together.

Our services are provided through support of our partners in local government through the Local Authorities, HSE, and other donors and funders.

### **Delegation and Reporting**

The Night Team Leader has decision-making remit for the areas of identifying appropriate housing and support needs in collaboration with clients and colleagues within the staff team and Head of Services. In the absence of Group Service Manager, or at times, the Night Team Leader may be required to consult with and take direction from Head of Operations or the CEO.

Oversight for the work in this role is provided by the Quality Services Sub Committee of the NOVAS Board of Directors.

The Night Team Leader will always operate in a professional and respectful manner, maintaining high quality standards of work in in accordance with the values and mission of NOVAS. Their decision making will always be informed by the best interests of the clients and ensuring cost effective value for money, use of donations and public money.

### JOB DESCRIPTION



The nature of our work involves supporting the most vulnerable people who often have complex needs and may be survivors of trauma. As a result, during the course of your work you may engage with sensitive and confidential matters that require empathy, compassion and pragmatism. You may also encounter clients or tenants who are in distress, displaying challenging behaviours or struggling to moderate their behaviour. Patience, respect and an ability to remain professional and focused on deescalating is essential. Further training will be provided in Trauma Informed Practice or Crisis Prevention.

As an organisation that is largely funded by public money, effective use of resources is a continuous focus and challenge.
