## **ROLE SUMMARY**

The purpose of the role is to build and sustain the 2into3 Funding team's position as a leading funding advisory partner in the nonprofit sector. This will be achieved through:

- Managing the end-to-end process for all assignments, including directly interfacing with clients to ascertain their needs to attract public finance.
- Proactively seeking and securing new business opportunities, both from existing 2into3 clients and prospective clients.
- Supporting the smooth-running and continuous improvement of the Funding Services team.

- Manage the end-to-end delivery of assignments using 2into3's processes, including client and stakeholder communications, project delivery, and preparation of recommendations.
- Utilise quantitative and qualitative research methods to analyse data related to nonprofit
  organisations, including financial data, socio-economic data, regional strategies and alternative service
  providers.
- Carry out financial appraisals to evaluate the costs, benefits, and risks of potential projects or opportunities, ensuring decisions align with organisational goals.
- Manage multiple projects simultaneously, ensuring that deadlines and client expectations are met.
- Build strong relationships with nonprofit clients, serving as a trusted advisor and providing responsive support to their needs.
- Create clear and precise reports and presentations that highlight findings in an accessible format.
- Produce reports to government departmental standards such as Green Book Appraisals, Cost Benefit Analysis and Public Spending Code.
- Ensure the Director of Funding Services is kept informed of assignment progress, including possible risks to delivery and possible solutions.

#### **Business Development**

- Secure new assignments from existing and prospective clients to ensure a continuous pipeline is in place.
- Research prospective clients and assignments, attend prospective client briefing meetings with the Director of Funding Services and assist in the defining of project methodologies and budgets.
- Manage the relationship with clients of strategic value with a view to securing further assignments and fostering partnerships with organisations.
- Keep abreast of business development opportunities including requests for tender and framework agreements.
- Support with marketing including pitching and writing communications pieces, identifying and leveraging marketing opportunities, and networking.
- Help to build and sustain the 2into3 Funding team's position as a leading funding advisory partner in the nonprofit sector.

- Maintain up-to-date information on prospective and current clients using tools such as Salesforce to record and maintain in a confidential and professional manner.
- Monitor and analyse trends in the nonprofit sector, specifically related to Funding Services.
- Contribute to the continuous development of all systems, processes and resources to support the funding practice.
- Create insightful reports and presentations that communicate data-driven findings and actionable insights to clients and internal teams.
- Keep informed of government strategic financial decisions and conduct in-dept research on government funding programmes at a local regional, national and European level.
- Analyse key performance indicators to inform the economic feasibility of a project and its potential to attract specific funding sources.
- Support the Director of Funding Services with onboarding and training new members of the team.
- Assist the Director of Funding Services by participating in organisational development, strategic planning and budget planning with other members of the organisation.
- Participate as a full member of the team and contribute to all meetings and team development sessions.
- Act in accordance with the ethos of 2into3's mission.
